HANDLING STATEMENTS:

Food Safety Requirements: Cargill Cocoa & Chocolate GMP's (SOP LGG-008 rev. 07/03/06) are to be followed by employees working with Cargill Cocoa & Chocolate products. All packing equipment must be thoroughly cleaned & sanitized before running each of the following categories of products and when switching from one category to another: semisweet (dark) products, milk-containing products, and nut-containing products.

If available, all finished product is to be run through a metal detector with sensitivity to detect 0.8mm Ferrous test rod and a 0.8mm non-Ferrous test rod. Monitoring frequency, metal detector test procedure, and malfunction protocol are to be completed as described in procedure COP 004.

Traceability Requirement: All finished product containers and product cases from 50 lb. boxes through 5.5oz. boxes must have two lot numbers on them for Lot identification; one lot number identifies the date bulk chocolate was produced at Cargill Cocoa & Chocolate, the other indicates the date and shift buds were moulded, as described in procedure COP 002.

Packaging:

Total weight = 5lb minimum.; 4boxes/case; approx. 20 lbs. per case

Special Instructions: The following are to be included with each shipment:

- 1. Bill of Lading listing product type, lot numbers, cartons size, and number of cartons in shipment.
- 2. For each lot Number shipped a copy of COP 004 Quality Control Audit Bud Form.
- 3. Above document should be in an envelope marked "Attention Quality Assurance Manager".

Storage: All Cargill Cocoa & Chocolate product must be stored in temperature & humidity controlled environment (70oF max, 65% RH max) and away from strong odors. Packaging materials must be stored away from strong odors.
